### Directions for Use

#### DESCRIPTION

The WarmGel® Infant Heel Warmer with Lift & Stick Tape is a disposable heel warmer for use when circulation needs to be stimulated in the newborn or infant heel in order for blood sampling to occur. When the Infant Heel Warmer is activated at 75° F (24° C), the temperature of the Infant Heel Warmer rises from 75° F (24° C) to a maximum of 107° F (42° C), then gradually diminishes over time.

#### INDICATIONS FOR USE

An instant warm pack intended to be used on an infant's heel to increase blood circulation to the area to aid in the drawing of blood for analysis. It is a single use, non-toxic, non-sterile, disposable warmer.

The device is primarily used in hospitals, doctor's offices, and other healthcare facilities.

2. Flex (bend) disc rapidly until crystals begin to form.
3. Place on heel. Remove the paper strip that covers the adhesive strap. Place around the foot, carefully placing the sticky part of the strap to the bag. Be careful not to adhere to the skin.
4. **Do not leave on skin longer than 10 minutes.**
5. Do NOT apply a covering or wrap around the Infant Heel Warmer that has been placed on the infant's foot.
6. Dispose of appropriately.




